## **Lake Preservation Committee – Bill Rush**

Bill Rush talked about the roadway that leads to the back where the tree fell has washed out quite a bit of land. The last inspection in July by John showed it is erosion, and it is estimated that it has eroded about six inches. Bill suggested that the town try and find someone who would be willing to put some large rip-rap there. There had been discussion of cage rip-rap, but Bill explained that that is very, very expensive.

Birmingham Water Works dredging equipment is back up and running. Greg Posey, Sid Nelson and Bill Rush are going to work on scheduling a time to go and talk with the workers.

Bill Rush and Wayne Bailey are rotating off committee. Bill is willing to be up for reelection but Wayne has requested to remain off.

Mayor Moore reported that Johnny Mayfield from Birmingham Water Works has persuaded them to waive the water testing fees for this quarter and last quarter. He does not know how long this will continue, but thanked Wayne Bailey for passing Mayfield's contact info to him.
