ORDINANCE NO. HL 93-09

AN ORDINANCE TO AMEND ORDINANCE NO. HL 88-02 AN ORDINANCE TO ADOPT THE STATE LAWS BY REFERENCE

SECTION 1: Misdemeanor.

Any person or corporation committing an offense within the corporate limits of the Town of Highland Lake, Alabama, or within the police jurisdiction thereof, which is declared by a law or laws of the State of Alabama now existing or hereafter, enacted to be a misdemeanor, shall be guilty of an offense against the Town of Highland Lake, Alabama.

SECTION 2: Violation.

Any person or corporation committing an offense within the corporate limits of the Town of Highland Lake, Alabama, or within the police jurisdiction thereof, which is declared by a law or laws of the State of Alabama now existing or hereafter, enacted to be a violation, shall be guilty of an offense against the Town of Highland Lake, Alabama.

SECTION 3:

Any person or corporation committing an offense with the corporate limits of the Town of Highland Lake, Alabama, or within the police jurisdiction thereof, an offense as defines by Section 13A-1-2 of the Alabama Criminal Code, which offense is not declared by a law of laws of the State of Alabama now existing or hereafter enacted to be a felony, misdemeanor or violation, shall be guilty of an offense against the Town of Highland Lake, Alabama.

SECTION 4:

Any person found to be in violation of Section One (1), Two (2), or Three (3) of this Ordinance shall, upon conviction, be punished by a fine of not less than One Dollar (\$1.00) no more than Five Hundred Dollars (\$500.00) and or may be imprisoned or sentenced to hard labor for the town for a period not exceeding Six corporation found to be in violation of Section One (1), Two (2), or Three (3) of this ordinance shall, upon conviction, be punished by a fine of not less than One Dollar (\$1.00) no more than Five Hundred Dollars (\$500.00) at the discretion of the Court trying the case.

SECTION 5:

Any person found to be a violation of Section 32-5A-191, Code of Alabama, 1975, as amended, shall, upon conviction be punished no more than Five Thousand Dollars (\$5,000.00) and or may be imprisoned or sentenced to hard labor for not more than one year.

SECTION 6:

Any ordinance heretofore adopted by the Town Council of Highland Lake, Alabama, which is in conflict with this ordinance is hereby repealed to the extent of such conflict.

SECTION 7:

If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding.

SECTION 8:

Be it ordained that by this Amendment, Ordinance 88-02 shall supersede and repeal Ordinance HL 83-3, dated 16th day of May 1983.

SECTION 9:

This ordinance shall become effective upon adoption and publication.
