# Regular Meeting of the Town of Highland Lake, Alabama

The Highland Lake Town Council held its regular meeting on Monday, October 3, 2016 at the Anchor. Mayor Bailey called the meeting to order at 7:00 p.m. Skip Davis gave the invocation. The Mayor led the pledge of allegiance.

September 12, 2016 Regular Meeting Minutes – Davis made a motion to approve the minutes, as written. Hanby seconded. Roll call. All voted yes. Motion carried.

**Financial Report** —Council member Vice gave the monthly and end of fiscal year financial report. Vice reported the net income for the year was \$39,577.80. Also, Vice reported the town started the fiscal year in October 2015 with a total of \$303,974 cash and CD's. The town is ending this fiscal year with \$349,703. Ort made a motion to accept the report, as presented. Hanby seconded. Roll call. All voted yes. Motion carried.

## **STANDING COMMITTEE REPORTS**

**Buildings & Grounds** – Chairman Donna Hanby reported the entrance sign at River Road/Lakeshore Drive has been re-installed. A work day was scheduled for Thursday, October 6 to stain the posts and plant flowers.

**Roads** – Chairman Tim Peek – no report.

**Lake** – Chairman Skip Davis requested the town contract with Johnny Dailey and Don Martin to do maintenance work at the dam since they are familiar with the project. Davis stated the maintenance project at the dam has not been totally defined, but the cost should be under \$30,000.00 as budgeted. This is a public works project and does not need to be bid if under \$50,000.00.

**Ordinances** – Chairman Shani Ort reported the Zoning ordinance will be voted on tonight later in the agenda.

Mayor Bailey reported the county is currently working on Lakeshore Drive, and will pave from CR29 to Carl Randall's house (where they left off last time). Work will also be done in the S curve by Edna Henry's house on Lakeshore Drive to the entrance of the Anchor. The county will also place one coat of tar & gravel from CR 29 to the Anchor. The county should pave this portion of Lakeshore Drive in the next few weeks. This is a matching grant with the county.

**Drone Video of Lake** – Council member Vice requested that the town have a video taken of the lake while the water is down, especially the areas where we are going to dredge. Cullman Aerial Photography will do still shots and a video for \$500.00. Vice made a motion to hire Cullman Aerial Photography to do a drone video of the lake. Ort seconded. Roll call. All voted yes. Motion carried.

Ort made a motion to suspend the rules and amend the agenda to review three additional requests that were received after the agenda was posted. Vice seconded. Roll call. All voted yes. Motion carried.

**Jadie Barwick – install fence to edge of seawall**. Vice made a motion to approve. Ort seconded. Roll call. All voted yes. Motion carried.

**Vance Morton – repair seawall**. Vice made a motion to approve plans. Davis seconded. Roll call. All voted yes. Motion carried.

Terry Thurston – cut 6 ½" off of piles and reset pier. Hanby made a motion to approve plans. Ort seconded. Roll call. All voted yes. Motion carried.

The Mayor stated the Lake Committee is addressing options for removing dirt from the boat launch area.

Mayor Bailey read her last article from the October community newsletter. She expressed her appreciation to the council and to the employees. Mayor Bailey stated Highland Lake is one of the most wonderful places on earth in which to live and we have some of the greatest citizens anywhere.

## The Mayor opened the meeting to the public.
