Lake – Chairman Nelson reported the committee met and rode around the lake to identify issues. Several trees were identified that need to be removed when the lake is lowered next.

Dredging – Chairman Malek reported the contract with Tetra Tech can be extended to December 2019 or the project can be closed out. The town would not have to pay the remaining balance of the contract.

Roads – Chairman Moore reported once the Lakeshore Loop project is completed, the county plans to work on Lakeshore Drive from the Brasher Creek Bridge to the Sunset Blvd hill area. Moore also reported a Road Form had been received to connect the culverts under Lakeshore Drive and the Goodner Farm Road area. These culverts cannot be connected without engineered drawings per Commissioner Calvert.

Ordinance – Chairman Hanby reported she will work on the Employee Pay Scales resolution.

Appalachian High School Classroom Grant – Blount County Education Foundation Radio-thon - Nelson made a motion to approve a \$750.00 grant to Appalachian High School. Hanby seconded. Roll call. All voted yes. Motion carried.

Cameron Adams – Eagle Scout Community Project – Cameron Adams presented to the council four options for the park: (1) Four benches, (2) four park benches, (3) two picnic tables and (4) an arbor. Cameron stated he would raise the funds needed for the project and would do the maintenance. Moore made a motion to approve an arbor for the park. Hanby seconded. Roll call. Nelson, Malek, Hanby, Moore and Vice voted yes. Adams abstained. Motion carried.
